# Introducing the Top 25 Essays of the St.Gallen Symposium Global Essay Competition

Each year, the Global Essay Competition of the St. Gallen Symposium receives hundreds of submissions, out of which twenty-five stand-out contributions are selected by a Jury. These essays are authored by a promising generation of future leaders from across the globe. The participants respond to a thematized call that revolves around the primary theme of the annual St. Gallen Symposium. As a result, these young talents delve into a range of interconnected topic areas that seldom discussed combinations outside of the Symposium. The essays present innovative ideas that tackle some of the significant challenges that we confront today. Their problem statements are thought-provoking, and their solutions are inventive and forwardthinking. These writings spark vital conversations about our future during and beyond the Symposium. Facilitating this dialogue every year and connecting

these young, inspired thinkers with today's decision-makers and influential organizations are among the primary objectives of the St. Gallen Symposium.

A great deal of our lives is influenced by when we were born. As those currently alive, we have inherited a world built by previous generations. We owe a great deal to the efforts of our forebears, but we also inherit problematic legacies. This year, 700 participants of the Global Essay Competition examined the most relevant legacies in our world today. The authors of these essays distinguished between three types of legacies. One group of essays focused on legacies from the past that are no longer serving us or have perhaps never served societies at large. A second group of essays examined legacies that need to be transformed and updated to reflect the complexities and interdependencies of our world. Finally, the third group of essays provide food for thought on future legacies that we should proactively create today to ensure the

prosperity and wellbeing of future generations.

#### The significance of legacies

The authors of the top 25 essays define "legacy" as the impact or influence that an individual or group leaves behind, often in the form of achievements, ideas, or values. Legacy can also refer to the tangible or intangible assets that an individual or group leaves behind, such as works of art, literature, or scientific discoveries. In many cases, a legacy is down from generation passed generation, shaping the future in significant ways. Different generations have different ideas about legacies, which can result in tension and conflicts about what is considered valuable and worthy of passing down. The fact that the authors approached the topic of legacy in signals different ways the uncertainties they are observing in our globalized world. Some legacies, such as climate change, fundamentally affect every living being on Earth and have longterm consequences that will shape the future. Other legacies, such as the impact of social media, may only affect small groups but still have significant impact. # **Leaders of Tomorrow Call for Immediate Action**

universal healthcare were restoring proposed to meet changing societal needs. Legacies can be politicized, weaponized, or abused for future resources, whereas bad legacies entail discrimination, environmental damage, and exploitation. Limited knowledge, like social media's health risks, makes some legacies ambiguous. For instance, an essay on artificial intelligence (AI) calls for open-source research and an expanded ethical understanding of Al use cases. The authors agree that renewing legacies responsibility, our requiring collaboration from individuals to global institutions. Interdisciplinary approaches allow a holistic understanding of legacies' impact on society.

## Preserving our legacies by embracing diversity and inclusion

A key theme that emerges from the essays is the importance of preserving and updating our legacies through embracing diversity and inclusion in our ever-evolving societies. Some ideas are worth preserving, while others need to be updated to fit the changing times. For example, authors suggest that philanthropy is a good legacy that however needs updating. The authors caution that philanthropy needs to evolve to address the root causes of societal issues rather than just treating their symptoms. One actionable idea is to create a new model of philanthropy that focuses on systemic change rather than individual aid. Another good legacy worth preserving is healthcare, but it also needs updating. The respective authors suggest that healthcare systems need to be more accessible and affordable, especially for marginalized groups. One actionable idea increase the availability telemedicine and digital health solutions to reach people in remote or underserved areas. Finally, corporate social

responsibility (CSR) is an idea that needs both preserving and updating. While CSR initiatives are important, the authors argue that they need to go beyond tokenism and become integrated into a company's core values and operations. One actionable idea is to create diversity and inclusion training programs employees and to increase the representation of diverse voices in leadership positions. By embracing diversity and inclusion in our legacies and updating them to fit the changing times, we can create a more equitable and sustainable future.

## Confronting uncomfortable truths: abandoning harmful legacies

As the authors of these essays demonstrated, taking a balanced yet critical view of our legacies is key to achieving these goals.
